All My Papers Releases X9 VIEWER for Image Cash Letters

Saratoga, CA – May 2, 2007 – All My Papers (AMP), a developer and distributor of software products that address critical interoperability and data integrity issues for check image exchange, announced today its latest release of the **X9 VIEWER** for Image Cash Letters (ICLs). ICLs are also known as X9.37 and X9.100-180 files, and in Canada as TECP files. The **X9 VIEWER** application enables accurate viewing, validation, and editing of ICL's. Additionally, the AMP **X9 VIEWER** enables the selective printing of Image Replacement Documents (IRDs), allowing for easy selection and printing as an IRD items that cannot be exchanged electronically. The **X9 VIEWER** is a Windows™ .NET application used to identify and resolve issues in check Image Cash Letter files and is a valuable tool for testing interoperability and maintaining data integrity.

The **X9 VIEWER** is designed for anyone working with or implementing a system that will process ICLs. The application will reduce implementation costs, time and ongoing maintenance efforts, and can be used in many financial institution departments such as:

- *Operations* – to fix errors in X9.37 Files and auto-rebalance the image cash letter, validate the ICL for conformance to check image exchange guidelines, view BOFD information, certify files sent to and received from exchange partners, view Record 61 Deposit information
- *Testing* – to view files before IRD print, conduct conformance testing to exchange guidelines for ICLs, Quality Assurance testing, compare check images to record and field data and create test files
- *Software Development* - highlight non-conforming errors to standards and guidelines, disassemble X9.37 to CSV components for loading into internal databases,

Built on the .NET Framework, the **X9 VIEWER** displays check images as well as the file, cash letter, bundle and item structure of X9 files using any Microsoft Windows operating system. It also analyzes X9 files to validate each record's format and contents, and supports automatic and manual correction of standard validation errors. Key **X9 VIEWER** functions include:

- View check images and corresponding record and field detail
- Conformance testing to the X9.37 DSTU 2003, X9.100-180 and Canadian TECP
- Edit routing numbers, account numbers or delete an item or bundle and automatically rebalance.
- Print IRDs with a duplex laser printer with MICR toner that is HP PCL5e compatible

“The **X9 VIEWER** is a software application whose value increases with the exponential growth of Image Cash Letter exchange” said Larry Krummel, President of All My Papers. “When a financial institution finds a bad item in a 25,000 item cash letter, it needs to be quickly deleted, the ICL rebalanced, and the new file sent off to meet the deadline. The **X9 VIEWER** gives these institutions a simple, fast and cost effective tool to do that and many other functions.”
